COVID 19 Waiver

Assumption of the Risk and Waiver of Liability Relating to Coronavirus/COVID-19

The Stockyards City Main Street Program has put in place precautionary measures aimed at preventing and reducing the spread of COVID-19 among participants in the Cowboy Christmas Parade, to be held on Saturday, December 4, 2021. However, the Stockyards City Main Street Program cannot guarantee that you (or those you come in close contact with) will not become infected with COVID-19. Further, attending the Cowboy Christmas Parade could increase your risk of contracting COVID-19.

By registering for, signing below and participating in the Cowboy Christmas Parade, you acknowledge the contagious nature of COVID-19 and voluntarily assume all risk that you may be exposed to or infected by COVID-19 and that such exposure or infection may result in personal injury, illness, permanent disability, and death to you or those with whom you come into close contact.

You further acknowledge and agree to accept sole responsibility for any injury (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, to you or those with whom you come into close contact, including all participants associated with your entry in the Cowboy Christmas Parade. You hereby release, covenant not to sue, discharge, and hold harmless the Stockyards City Main Street Program, its employees, board of directors, and representatives, of and from any Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto.

You further understand and agree that this release includes any Claims based on actions, omissions, or negligence of the Stockyards City Main Street Program, its employees, board of directors, and representatives, whether a COVID-19 infection occurs before, during, or after participation in the Cowboy Christmas Parade on December 4, 2021.

You agree to abide by posted rules, warning or instructions by Stockyards City Main Street, and any government authority with respect to social distances, adherence to any dress code (including mandatory face coverings) and sanitation guidelines.

You further agree not to participate in the Cowboy Christmas Parade if you are diagnosed with or suspect that you may have been infected by COVID-19, and in the event you become ill or suspect you have been infected with COVID-19, you agree to immediately discontinue your participation in the event and alert the Stockyards City Main Street Program via e-mail or telephone.

If you cannot agree to or accept the foregoing, DO NOT PARTICIPATE IN THE COWBOY CHRISTMAS PARADE. Failure to agree to or abide by any of the foregoing may result in denial of entry or immediate expulsion from the Cowboy Christmas Parade, in the Stockyards City Main Street Program's sole discretion.

RELEASE, HOLD HARMLESS AND INDEMNITY AGREEMENT

Stockyards City Main Street is sponsoring a Cowboy Christmas Parade to be held on December 4, 2021. The undersigned requests they be granted permission to participate in the parade by sponsoring a parade entry ("permissive entry"). In consideration of permissive entry into the parade, the undersigned, on behalf of themselves, their personal representatives, heirs, and assigns, agree to the following terms and conditions:

The undersigned agrees to indemnify and hold Stockyards City Main Street and its Board of Directors and the City of Oklahoma City harmless from any and all claims and expenses arising from the participation in aforementioned parade, including, but not limited to, any claims which might be made by members or invitees of the undersigned or any member of the public participating with the permission of the undersigned or any independent third parties injured through operation of the entry.

The undersigned releases and discharges Stockyards City Main Street and its Board of Directors, staff, and volunteers and the City of Oklahoma City ("Releasees") from any and all claims and liability arising out of strict liability or negligence of the Releasees or any other participant in the parade which cause the undersigned injury, death, damages or property damages. The undersigned understands and agrees Releasees shall have no liability whatsoever to any persons participating in the Cowboy Christmas Parade.

The undersigned further agrees to hold harmless the Releasees from any and all claims made against the undersigned, and to indemnify the Releasees for any claims, damages, attorneys' fees and costs, arising from the undersigned's participation in the parade. The undersigned agrees this agreement shall apply to the Cowboy Christmas Parade scheduled on the date referenced herein or on any rescheduled date required by weather conditions or other unforeseen events.
